Lake Plan Update

Goal: Reduce invasive species infestation to less than 5% of Coon Lake's area.

2009 treatment summary

 CLID treated 73 acres of EWM (eurasian water millfoil) with triclopyr herbicide on July 23, 2009. Kill met the 90% kill goal for the area treated and 2010 growth infestation of this area is significantly reduced. The treatment company was Professional Lake Management(PLM), out of Pequot Lakes.

What's new from last year

 For 2010-2014, the east lake is in a DNR bay wide pilot project program for CLP (curly leaf pond weed). Most of the expense of the Spring treatment of the east lake was reimbursed by a grant.

 2010 was the first known treatment for CLP in Coon Lake.

2010 treatment summary

- 78 acres of the lake was treated for CLP in April. (Expected treating all or nearly all CLP in the east lake as per the stated pilot project program purpose)
- 53 acres of the lake was treated for EWM in July. (Requested 143 acres)

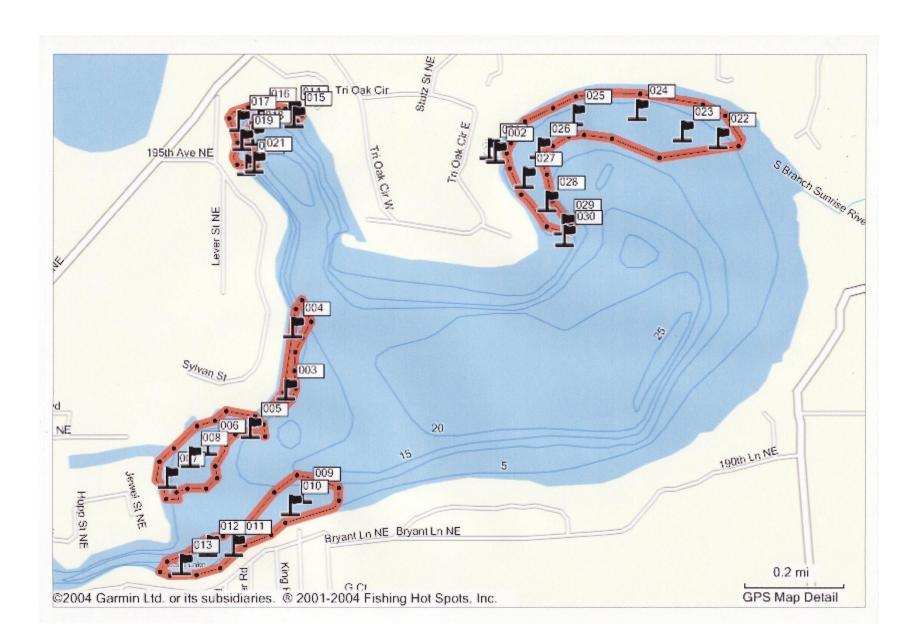
Reasonably good progress. Disappointing that DNR didn't approve proposed treatment.

2010 treatment summary

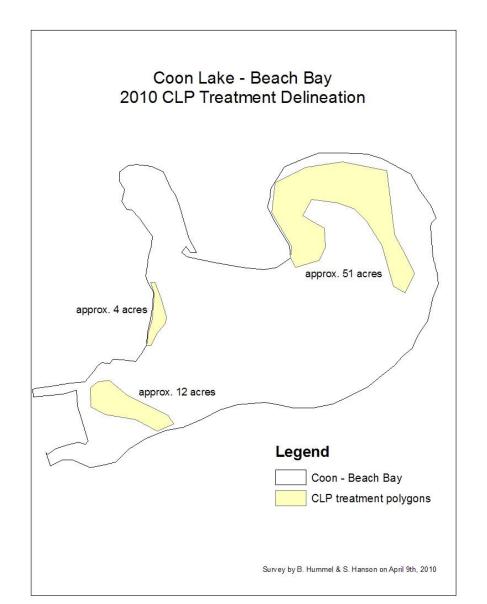
- For 2010, the east lake is in a DNR bay wide pilot project program for CLP. Most of the expense of the spring treatment of the east lake was reimbursed by a grant of \$15,000.
- Applied for and received a grant for \$7,800 partially reimbursement for EWM treatment.
- Lake Restoration, treated the east lake and Professional Lake Management (PLM), treated the west lake.

Reasonably good progress. Disappointing that DNR didn't approve proposed treatment.

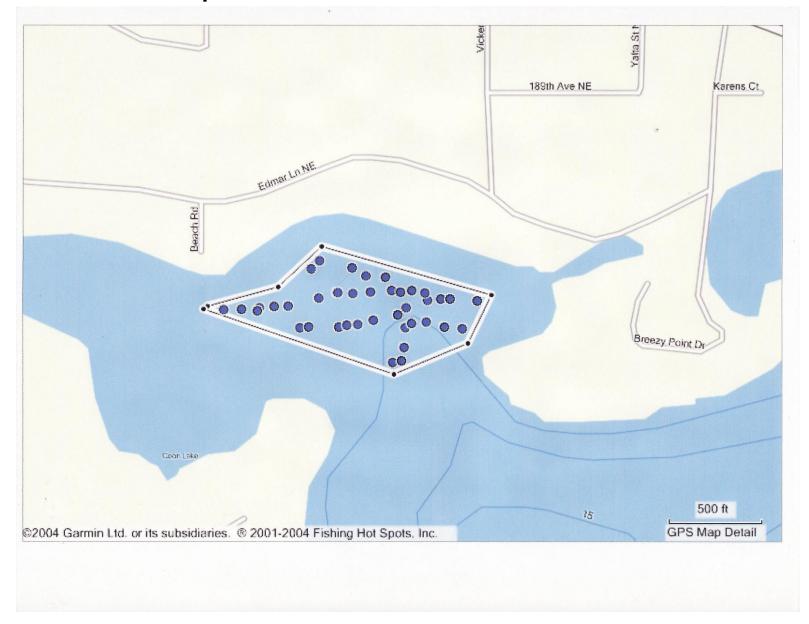
2010 CLP request treatment of the East Lake

2010 CLP requested and treatment of the West Lake



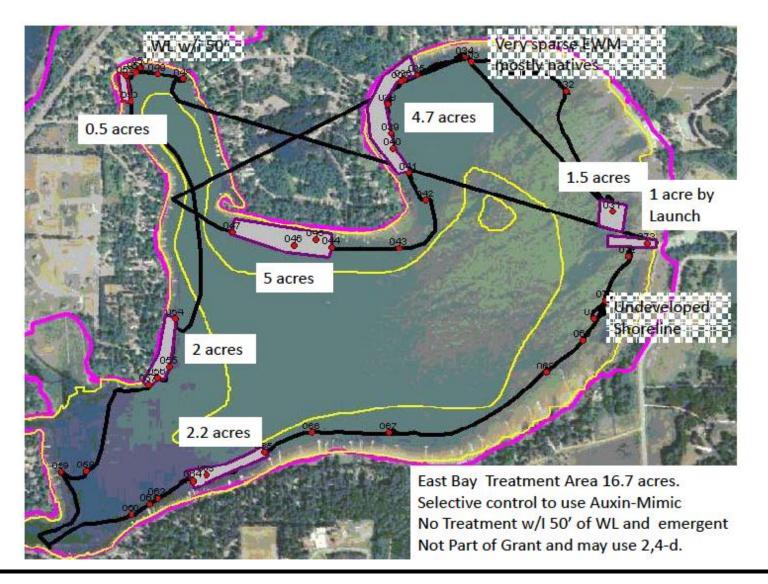
2010 EWM requested treatment for East Lake

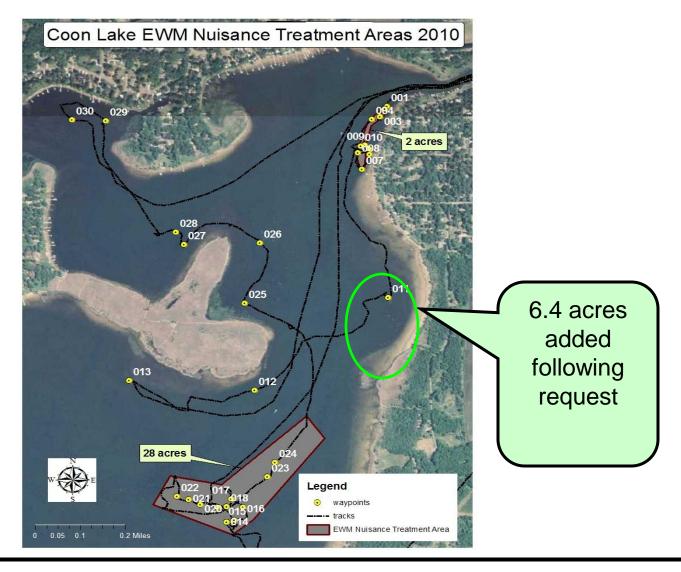

2010 Progress

- Spring CLP treatments were done early May, on time.
- The lake is significantly improved, less infestation with EWM and CLP.
- Water clarity on the east lake is better. The algae seems to be reduced due to CLP treatments.

2010 Progress

- CLID was able to get grants for significant reimbursement for both CLP and EWM treatments.
- A Lake Vegetation Management Plan was completed with MN. DNR, theoretically allowing for more acreage to be treated.





Disappointments and areas needing more work

 MN DNR has limited treatment for CLP and EWM to a fraction of what was requested. There are a number of infested areas that will go untreated this year. CLID requested treating 143 acres of EWM; only 53 acres were allowed.

We will need to put a lot more pressure on DNR to approve areas and commit to a timely response on permits and approvals.

Disappointments and areas needing more work

 As with last year, it took much longer than planned to get EWM permits approved. The permit application was submitted in January and updated in early May. DNR approved the end of June.

We will need to put a lot more pressure on DNR to approve areas and commit to a timely response on permits and approvals.

Disappointments and areas needing more work

 For the annual lake vegetation assessment, (our previous provider is not available). A new contractor will have to be identified and hired, probably at increased cost. CLIA has historically paid for this survey but may not be able to this year depending on cost.

We will need to put a lot more pressure on DNR to approve areas and commit to a timely response on permits and approvals.

What we learned

- Early spring CLP, Curly Leaf Pond Weed, treatments appear to be very helpful improving water quality.
- The majority of next year's lake treatment must be funded by this year's assessment.
- It takes a lot of time and effort to negotiate treatment area permits with the DNR. Start earlier.

Things will change, we will learn more, CLID needs some flexibility to react.

Proposed 2011 Plan

- Continue the early spring, bay wide treatment of the east lake for CLP.
 Expand spot treatment for CLP on the rest of the lake.
- Get EWM treatment done earlier in 2011.
 Push to treat more acreage than in 2010.
- Follow up with later spot treatments as appropriate.
- Conduct the annual August professional aquatic vegetation survey.

Can't count on grants in 2011.

Coon Lake Improvement District 2010 Annual Meeting Motions

Motion for Projects over \$5,000.00

\$120,000 for treatment of Eurasian Milfoil and Curly leaf Pondweed in 2011 as part of the Lake Vegetation Management Plan to control invasive species.

\$25,000 for Vegetation Surveys, either pre or post treatment, to identify areas for treatment, or to assess treatment results as prescribed by the DNR.

Motion for Special Tax Assessment

Reduce assessment by 50% from \$300 to \$150 each for the current property owners of record for a total of \$65,000.

Motion for the 2011 Proposed Budget

2011 budget of \$155,100 including administration expenses.
